Paying Interest	Your due date is at least 25 days after the close of each billing cycle. We will not charge you any interest on purchases if you pay your entire balance by the due date each month. We will begin charging interest on cash advances and balance transfers on the transaction date.

Other Disclosures:

Late Payment Fee	\$25.00 or the amount of the required minimum payment, whichever is less. In the event you fail to make a payment on time in any of the six (6) billing cycles following the violation, you will be charged \$35.00 or the amount of the required minimum payment, whichever is less.
Returned Payment Fee	\$25.00 or the amount of the required minimum payment, whichever is less, per returned payment
Statement Copy Fee	\$2.00 per statement
Rush Fee	\$20.00 per card
Card Replacement Fee	\$25.00 per card
Research Fee	\$20.00 per hour, minimum of one (1) hour
Stop Payment Fee	\$28.00 per request

Periodic Rates:

The Purchase APR is **9.75%** which is a monthly periodic rate of **0.8125 %**.
 The Cash Advance APR is **12.75%** which is a monthly periodic rate of **1.0625 %**.
 The Balance Transfer APR is **12.75%** which is a monthly periodic rate of **1.0625 %**.

Variable Rate:

The ANNUAL PERCENTAGE RATE is subject to change on the first day of the billing period following the month in which the rate is calculated to reflect any change in the Index and will be determined by the Prime Rate on the 3rd Tuesday of March, June, September, and December of each year as published in The Wall Street Journal "Money Rates" table to which we add a margin. The ANNUAL PERCENTAGE RATE will never be greater than **23.99%**. Any increase in the ANNUAL PERCENTAGE RATE will take the form of additional payments shown as Total Minimum Payments on the statement. If the Index is no longer available, the Credit Union will choose a new index which is based upon comparable information.

Margin:

Purchases will be charged at **6.50%** above the Index.
 Cash advances will be charged at **9.50%** above the Index.
 Balance transfers will be charged at **9.50%** above the Index.
