<b>Penalty APR and When it Applies</b>	<p><b>18.00%</b></p> <p>This APR may be applied to your VISA or MasterCard Feature Category if: Your VISA or MasterCard Feature Category is more than 60 days past due.</p> <p><b>How Long Will the Penalty APR Apply?:</b> If your APRs are increased for this reason, the Penalty APR applied to transactions that occur after the increase may be applied indefinitely, and the Penalty APR applied to transactions that occurred prior to the effective date of the increase will apply unless 6 consecutive payments are received on or before the due date during the six-month period following such increase.</p>
<b>How to Avoid Paying Interest</b>	For VISA and MasterCard, We will not charge You interest on purchases if You pay Your entire balance owed each month within 25 days of Your statement closing date. For all Feature Categories, We will begin charging interest on cash advances and balance transfers on the transaction date.
