## Credit Union Advisory Council Members



**Chairperson Carla M. Decker** is the President and CEO of the D.C. Federal Credit Union. From 1994 to 2000, Ms. Decker served at the PAHO/WHO Federal Credit Union, initially as Operations Manager and later as President and CEO. Previously, she was a branch administrator at the Transportation Federal Credit Union where she served from 1988 to 1994.

**Vice Chairperson Rose Bartolomucci** is the President and CEO of the Towpath Credit Union in Kent, OH. Ms. Bartolomucci has been a credit union activist since 1977. Ms. Bartolomucci was recently appointed to as Deputy Superintendent for Credit Unions, the chief regulator for 200 State Chartered Credit Unions in the Ohio Department of Commerce, Division of Financial Institutions for the Credit Union Section.

**Bernard A. Balsis, Jr.** is currently the President of Independent Employers Group Federal Credit Union in Hilo, HI. He has been at IEG FCU for over 2 years. Cooperative Federal), a high-impact Community Development Financial Institution (CDFI) serving the urban core of Syracuse, NY. With credit union experience since 1982, he is responsible for financial management, strategic planning, policy development, and executive oversight. Mr. Ehrenreich is active in many facets of public life and serves as President of the CNY Chapter of the Credit Union Association of NY and is on the CUNA Consumer Protection Subcommittee.

Ms. Lo's ability to speak five languages enabled here to communicate with recent immigrants whose unfamiliarity with the American consumer financial market exposed them to high fees and interest rates and predatory practices. When Ms. Martinez became the President/CEO, BFCU had \$33 Million in Assets, 13,400 members, and approximately 35 employees, with 2 service locations. BFCU now has over \$114 Million in Assets, approximately 23,000 members, 107 employees, 4 office locations and 14 proprietary ATMs. Ms. Martinez was instrumental in obtaining the Community Development Financial Institution Certification for BFCU from the U.S. Department of the Treasury Community Development Financial Institution Fund in 2010.

Marcus Schaefer has served as President and CEO of Truliant Federal Credit Union since 1995. Mr. Schaefer currently serves on the Winston-Salem Chamber of Commerce Board of Directors and as first Vice Chairman.
