**REQUEST FOR ISSUANCE OF A SUBPOENA COMPELLING
THE ATTENANCE AND TESTIMONY OF DANIEL T. WALKER**

Pursuant to 12 C.F.R. § 1081.208, Respondents PHH Corporation, PHH Mortgage Corporation, PHH Home Loans, LLC, Atrium Insurance Corporation, and Atrium Reinsurance Corporation (collectively, “Respondents”) request this Tribunal to issue a subpoena compelling the attendance and testimony of Daniel T. Walker, Senior Vice President of Product Management and Chief Operating Officer, International Division, United Guaranty Corporation (“United Guaranty”), at the Hearing on Monday, June 2, 2014, at 9:00 a.m. Respondents have attached the proposed subpoena hereto as Exhibit A.

The plain language of Administrative Adjudication Rule 208(a) empowers Respondents to seek the issuance of one or more subpoenas requiring the attendance of a witness to testify at the Hearing. *See* Rule 208(a). Respondents respectfully request that the Tribunal issue the proposed subpoena seeking the attendance and testimony of Mr. Walker during Respondents’ case-in-chief, which, the Bureau has indicated, may begin as early as Thursday, May 29, 2014. Mr. Walker will be called to testify the following week, on Monday, June 2, 2014, at 9:00 a.m.

Respondents intend to seek testimony from Mr. Walker regarding his employment with United Guaranty, captive reinsurance arrangements entered into by United Guaranty, and negotiations and dealings with Respondents during this time. The requested testimony is reasonable in scope and relevant to, among other things, the Bureau's claims and Respondents' defenses.
