Nicole,

A review of UG's redactions reveals that the content redacted does not fit within the Protective Order's definition of "confidential."

The redacted content on page 7 of the brief refers to general portions of the UGI Trust Agreement – without recitation of, or reference to, any specific provision of the Trust Agreement - and then states a conclusion about the Trust Account. Similarly, footnote 4 on page 9 refers to the commutation of the UGI and Genworth agreements generally, and then states a consequence of the agreements having been placed in run-off. Respondents do not believe this content represents Competitively Sensitive Information or Confidential Commercial information.

Because such information does not fall under the Protective Order, we do not think it should be redacted. Please let us know by tomorrow if you disagree.
