APPENDIX A

Joint Report of the Parties on Compliance with the Tribunal's Modified Protective Order

The Tribunal's Order of August 1, 2014 modified the existing Protective Order in this proceeding and directed that Confidential Information, as defined in the Protective Order, be unsealed. This report is filed pursuant to the Tribunal's Order of September 3, 2014, concerning compliance with the August 1 Order.

Following the issuance of the August 1 Order, Enforcement, Respondents, and the five intervening third parties (Radian Guaranty Inc., United Guaranty Residential Insurance Company, Mortgage Guaranty Insurance Corporation, Genworth Mortgage Insurance Corporation, and Republic Mortgage Insurance Company) conferred, and on August 6, 2014, copies of the then-filed documents in this matter were distributed to the intervening parties for review and proposed redaction. By August 26, 2014, the parties had exchanged their proposed redactions of those documents. Meanwhile, the initial and response briefs filed on August 8 and August 28, 2014, respectively, by both Enforcement and Respondents, have now also been circulated to the intervening parties. Once all documents have been reviewed and redactions have been proposed, in the event of disagreement, the parties intend to meet and confer to attempt to resolve any differences.

The parties propose to submit an agreed-upon joint set of proposed public documents to the Tribunal by October 17, 2014. Alternatively, on that date, if the parties cannot reach agreement on all redactions, the parties propose to submit joint proposed documents to the Tribunal wherever possible, and to submit separate proposed public

documents where agreement has not been reached. The parties respectfully propose that, once the Tribunal has approved public versions of the relevant documents, the Office of Administrative Adjudication be directed to publish the public versions on its website within five days.
