Alusheyi: I have no problem moving his deposition, provided that the Bureau agrees to extend the date by which we must file a rebuttal expert report. That date is currently March 17, which means that if we move the deposition to March 11, we will have only 4 business days between his deposition and any rebuttal report. Is the Bureau willing to agree to move the date for the exchange of rebuttal reports to March 25?

Provided that the Bureau is willing to move the date for rebuttal reports back to the following week, as proposed, we have no problem rescheduling his deposition. And I think that Friday, March 11 should work (will confirm and get back to you shortly).

I hope that Dr. Hastak feels better soon.
