How to Avoid Paying Interest	Your due date is at least 25 days after the close of each billing cycle. We will not charge you any interest on purchases if you pay your entire balance (minus any excluded balance, plus any separately required payment on an excluded balance) by the due date each month. We will begin charging interest on a Major Purchase Plan balance at the start of the billing cycle following the billing cycle in which the Major Purchase Plan purchase was made.
Minimum Interest Charge	If you are charged interest, the charge will be no less than \$2.
