Paying Interest	<p>Your due date is at least 25 days after the close of each billing cycle. We will begin charging interest on cash advances and balance transfers on the transaction date. We will begin charging interest on a Major Purchase Plan balance at the start of the billing cycle following the billing cycle in which the Major Purchase Plan purchase was made.</p>
