REQUEST FOR ISSUANCE OF A SUBPOENA COMPELLING THE ATTENDANCE AND TESTIMONY OF E. QUINN MILLER

Carnes (collectively, “Respondents”) respectfully request that the Court issue the attached subpoena seeking the attendance and testimony of E. Quinn Miller, Investigative Supervisor, State of Delaware, Office of the State Bank Commissioner, at the Hearing to commence on July 19, 2016, at 10:00 AM, in the above-captioned proceeding.
