ORDER GRANTING FOURTH JOINT MOTION TO EXTEND TIME TO ANSWER NOTICE OF CHARGES AND HOLD SCHEDULING CONFERENCE

On November 22, 2016, this tribunal granted the Parties' Third Joint *Motion to Extend Time to Answer Notice of Charges and Hold Scheduling Conference*, extending the period of time for Respondent to Answer the *Notice of Charges* to December 16, 2016, and the time within which to hold the scheduling conference to December 21, 2016. On December 15, 2016, the parties filed a fourth joint motion requesting an additional seven-day extension to each of these timelines to finalize settlement discussions and documentation.
