POST-CONFERENCE SCHEDULING ORDER

On November 2, 2016, I conducted a telephonic scheduling conference in the above captioned case. Attorneys Rebecca Coleman and Amanda Krause appeared on behalf of the Consumer Financial Protection Bureau and Attorney Brian Schulman appeared on behalf of Respondent.

The parties stated that they are actively engaged in settlement discussions. Respondent requested that the due date for filing its answer be extended to December 2, 2016, to allow for settlement discussions to continue without having to unnecessarily expend time and resources preparing for hearing. Enforcement counsel expressed agreement with this timeline.

The parties agreed that if they have not reached settlement by December 2, 2016, a follow-up scheduling conference will take place the week of December 5, 2016, during which they will set forth a joint proposed schedule for the formal hearing in this matter.

Respondent also indicated that it desired the formal hearing be conducted in Phoenix, Arizona, if necessary. Both parties indicated that they do not require more than two days for a formal hearing.

ORDERS

1. Respondent's answer will be submitted no later than **December 2, 2016**.
2. A follow-up scheduling conference will be conducted the **week of December 5, 2016**, to be scheduled by separate order.
