

TCCP Survey Quick Reference Guide

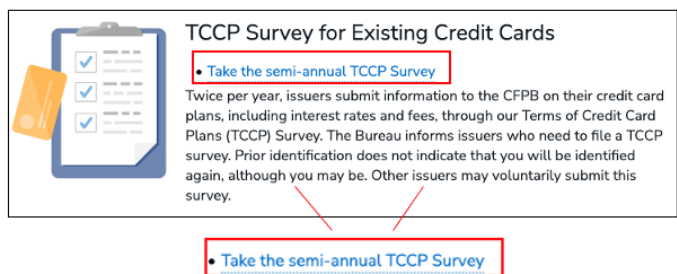
This document provides a high-level overview of how to submit a TCCP Survey using Collect. Please reference the Collect TCCP Survey User Guide, available on our website, for more detailed information.

The Consumer Financial Protection Bureau (CFPB), is required by law to collect certain credit card price and availability information from a sample of credit card issuers and report this information to Congress and make it available to the public, pursuant to provisions of the Truth In Lending Act (TILA), 15 USC 1646(b)(1), (2) & (4). If your financial institution received an order from the CFPB requiring completion of the Terms of the Credit Card (TCCP) Survey, your financial institution must complete and submit the TCCP Survey to the CFPB. Please refer to the order for requirements on how many surveys your institution must submit.

TCCP Survey Submission

Step 1

From the Community homepage, select **'Take the semi-annual TCCP Survey.'**



Step 2

Review the instructions provided on the page and select **'Start Survey'** to begin the Survey.

Step 3

If you've previously submitted a Survey using Collect, you can choose to pre-populate your next Survey with the previous Survey's answers by selecting the appropriate previous Survey from the dropdown list. Select **'Next'** to continue.
